CLERK'S REPORT A note has been received from the Montreat Conference Center thanking MPPC for our participation in its capital campaign.

SPECIAL ORDER: 110 BENNETT STREET Following a report by Dal Schreck and Lewis Horton, by common consent, the session agreed to move forward with selling the easement at 110 Bennett Street for \$8,500 to the new owner of that property with a reversion clause should the property be divided and with MPPC being granted access to tend to the fence along the property line. In accordance with G-4.0208, MPPC exercised that exemption at a congregational meeting on October 16, 1983 and will not have to seek approval of the presbytery.

DEACON TASK FORCE REPORT Following a report by Deacon J. Scott regarding changing from a family group model to a structured committee model a motion to approve a new model for the board of deacons was approved.

BUILDING AND GROUNDS Building use policies are being reviewed. The Scout Hut was re-roofed over the summer with the troop contributing \$3200 of the \$11,000 total cost.
