# <u>ACTION ITEMS FROM COMMITTEES</u> The following items were approved. \*The Finance Committee moved the approval of the following resolution:

RESOLVED BY THE SESSION OF MOUNT PLEASANT PRESBYTERIAN CHURCH, TO:

- Authorize and establish that the period from July 1, 2020 to and including December 31. 2020 shall be a fiscal year of the Mount Pleasant Presbyterian Church for all budgeting, accounting and stewardship purposes;
- Authorize and establish that the period from January 1, 2021 to and including December 31, 2021, and from January 1 to and including December 31 of each year thereafter shall be a fiscal year for Mount Pleasant Presbyterian Church for all budgeting, accounting and stewardship purposes:
- Authorize and establish that the period from July 1 to and including June 30 of each year shall continue to be a fiscal year for Mount Pleasant Presbyterian Church Learning Center for all budgeting and accounting purposes;
- Authorize and approve the extension of the current July 1, 2020 June 30, 2021 budget of Mount Pleasant Presbyterian Church for all accounts to include July 1, 2021 - December 31, 2021 on a pro-rata calculation of such budget, subject to any adjustments approved by the Session:
- Authorize the Finance and Stewardship Committee to request church members to 5. extend and continue their current estimates of giving for the period of July 1, 2020 – June 30, 2021 by adding the period from July 1, 2021 to and including December 31, 2021, and for such additional period to encourage increases in giving and to ask other members and other church participants to provide estimates of giving;
- Authorize and establish that an annual church-wide stewardship program will be held in the Fall of each year beginning in 2021 and continuing every year thereafter; and
- Authorize the Finance and Stewardship Committee to take all other reasonable or necessary actions to accomplish the changes of fiscal years and related matters all as provided by this Resolution.
